



OPERATING RULES FOR KITCHENETTES

Dormitories and Refectories of the University of South Bohemia in České Budějovice

Valid from 1 September 2026

OPERATION OF THE KITCHENETTES

- The kitchenettes are intended for use by students, staff and hostel guests accommodated in the USB dormitories (hereinafter referred to as 'Users') exclusively for the preparation of food and non-alcoholic drinks.
- The kitchenettes are open 24 hours a day.
- In the case of group use, Users bears full responsibility.
- In the event that the fire alarm system (FAS) is triggered, and the Fire and Rescue Service is dispatched unnecessarily, Users are obliged to pay a fine in accordance with the price list.
- Users are obliged to conserve electricity and water.

OBLIGATIONS OF USERS OF THE KITCHENETTES

- Users must use the appliances and equipment only for the purpose for which they are intended.
- For safety and fire safety reasons, users must not leave the kitchen while electrical appliances are in use (i.e. while preparing food). Should such a situation be detected, the appliance will be switched off and any items left behind will be removed by D&R staff without any entitlement to compensation.
- It is essential to keep the kitchen tidy! All Users of the kitchenette are obliged to tidy up after themselves immediately and remove any food leftovers. If the bin is full, do not throw any more rubbish into it! It must be taken out to the outdoor bins. Failure to comply with the rules may result in a fine; in the event of repeated breaches, the resident's accommodation may be terminated.
- Please treat all the facilities and equipment the kitchen in with care and do not damage them.
- Please report any faults, damage or defects to the equipment and facilities to reception immediately.
- Before leaving the kitchen, please ensure that all appliances are switched off, the water is turned off, all lights are switched off and the windows are closed.

PROHIBITED ACTIVITIES IN THE KITCHENETTES

- Smoking, the consumption of alcoholic drinks and intoxicating substances, and the use of open flames (particularly candles) are prohibited in the kitchenette.
- Deliberately damaging the facilities and equipment in the kitchenette and removing items from the kitchenette.
- It is forbidden to tamper with any installations or equipment (electrical wiring, water supply).
- Bringing in and using items that pose a risk to life and health, or items unrelated to the operation of the kitchenette.

Persons under the influence of alcohol or other intoxicating substances are prohibited from entering the kitchenette!

FINAL PROVISIONS

- When using the kitchenette, Users must comply with health and safety guidelines (risk of scalding, burns, etc.).
- In the event of damage to or loss of equipment, Users are obliged to pay for the damage caused.
- In the event of a breach of these Operating Rules, the operator reserves the right to expel the visitor from the kitchenette.
- D&R accepts no liability for personal belongings left unattended on the premises of the kitchenette.

In the event of a breach of these Operating Rules, Users are liable to a contractual fine of CZK 500.
